# LEGAL AID CENTER OF SOUTHERN NEVADA HONORS SNELL & WILMER WITH MULTIPLE PRO BONO AWARDS

LAS VEGAS (December 15, 2011) – Snell & Wilmer is pleased to announce that the firm, and several of its attorneys, received awards and recognition for their pro bono contributions to the local Las Vegas community by the Legal Aid Center of Southern Nevada. The awards were presented at the Legal Aid Center's 2011 Pro Bono Awards Luncheon. Snell & Wilmer was the recipient of the Lied Award as law firm of the year for contributing the most pro bono hours of any firm in Southern Nevada for 2011 (recording 1330 combined hours as a firm). In addition to the firm's recognition, Richard C. Gordon, a partner in the Commercial Litigation Group of the Las Vegas office, received the Lied Award for the most pro bono hours of an attorney in 2011.

Lied Awards are given in recognition of the Lied Foundation which gave the Legal Aid Center of Southern Nevada a Challenge Grant in 2000 to pay off its building mortgage. The grant is based on how many pro bono hours lawyers and law firms donate to the Legal Aid Center on a yearly basis.

Richard Gordon was also presented with the Myrna Williams Children's Pro Bono Award as Child Advocate of the Year for 2011. This award is given in honor of Myrna Williams, who was instrumental in helping establish a program for the legal representation of abused and neglected children in Southern Nevada, and recognizes an attorney who has done an extraordinary job in giving a voice to our community's most vulnerable victims. Gordon and a team of Snell & Wilmer attorneys, including Ray Jones, Brian Reeve and Kelly Dove, successfully represented three minor children (ages 5, 9 and 13) who sought reunification with their natural mother. The Snell team prevailed after a contentious 14 day termination of parental rights trial that lasted over a span of four months.
