RECOGNITION FOR SNELL & WILMER ORANGE COUNTY APPELLATE ATTORNEYS DEREVAN AND SUNGAILA

ORANGE COUNTY (October 15, 2013) – Snell & Wilmer is pleased to announce that two attorneys in the firm's Orange County appellate law group have received recent recognition. On October 14, Richard A. Derevan received the Orange County Bar Association's David G. Sills Award for Appellate Excellence and on October 10, Mary-Christine "M.C." The David G. Sills Award is a singular honor recognizing excellence in the Southern California appellate bar and bench. A California State Bar certified appellate specialist, Derevan has been lead counsel in more than 300 state and federal appeals and writ proceedings. The Orange County Bar Association Appellate Law section bestowed the first award in 2010 to its namesake, the Honorable David G. Sills, who served as Presiding Justice of the California Court of Appeal, Fourth District, Division Three, for 20 years. Later awards recognized Associate Justices Sheila Prell Sonenshine (ret.) and William F. Rylaardsam.

The Judith Soley Lawyer as Citizen Award is conferred only when, in the CWL board's view, a worthy candidate is presented. Sungaila, a partner at Snell & Wilmer, is the first to receive the award, which celebrates a lawyer who is an excellent, civil and honorable lawyer; possesses a demonstrated commitment and passion regarding civic and charitable engagement; values compassion and empathy along with advocacy when addressing clients' individual needs; works to improve the legal system through education and involvement in bar associations; participates in the public life of his or her community, state and nation; is a leader, a role model and mentor; and demonstrates a commitment to the mission of California Women Lawyers.

Derevan and Sungaila have both been recognized multiple times in *Chambers USA*: America's Leading Lawyers for Business, *The Best Lawyers in America*® and *Southern California Super Lawyers*® in the area of appellate law.
