Peay, Welch and Jones were recognized for their work on a civil rights case. After plaintiff's original counsel withdrew, the court ordered the Clerk's Office to find pro bono counsel. The Snell & Wilmer team agreed to take the case in 2017 and stayed the course with a four-year representation through 10<sup>th</sup> Circuit appeal and a jury verdict in 2021.
